The *Opticians Association of Washington* would like to invite you to exhibit at our *2017 Spring Convention & Tradeshow, April 22nd - 23rd, 2016 at the Semiahmoo Resort - 9565 Semiahmoo Parkway Blaine WA - Phone: 360-318-2000* Each space will be approximately 6ft x 6ft in size and will contain 1 - 6 ft skirted table and a chair. There will be no curtains or wall between the booths or backdrops. If electricity is required or if your display is tall and should be against a wall, let us know so that we can place you appropriately. If you want extra tables, they can be ordered through the OAW.

We are enclosing a formal "**Agreement to Exhibit**" which outlines costs and the rules and regulations that help govern our Tradeshow. Table tops are assigned on a first come basis, so be sure you return the Agreement with your check as quickly as possible. If your representative is local, be certain to include their address so the confirmation information can be sent directly to them. Approximately two weeks prior to convention, we will return to you a floor plan with your booth assignment and other pertinent information about the Tradeshow. If you know you are coming, but company checks take awhile, please fax over the agreement with a note telling us when the check is coming so that we can get your booth assigned.

The Tradeshow will be on **Saturday, April 22nd-23rd 2017** You can make your reservations at **360-318-2000**. The Tradeshow will be open from 10:00 a.m. until 1:30 p.m., with a buffet lunch served to opticians adjacent to the Tradeshow area. The luncheon will be by ticket only so that the Tradeshow can be open the entire time to any opticians or optical personnel that want to attend. Please pass this information along to your accounts that may want to see your line at the show. You may tear-down your booth, at approximately 1:00 p.m.

Buffet luncheon for those wholesalers purchasing booth space will be provided at about 12:00 p.m. until 1:30 p.m. This will allow you to eat during or after the show. If your schedule allows, the OAW would enjoy your company at the hospitality suite after dinner Saturday night. Dinner tickets can be ordered on the agreement or at the convention. Exhibitor agreements are due back **February 28th 2017. Second booth spaces are available at reduced rates;** but we cannot allow multiple companies to combine within booths. However, one company with multiple representatives or one representative with multiple lines may take advantage of this offer. OAW makes final determination.

For those of you who would like to stay at the Red Lion Vancouver, WA, we have arranged for reduced rates for the weekend. If you call for reservations before the 1st of March and mention the Opticians Association, the rates are : **Room rate will be \$159 per night**
